## **4.1 For Parish Council Comment**

10/20/00007/STP – Land to the West of Owls Hill Barn – outline application with all matters reserved for the erection of an agricultural workers dwelling and garage.

A letter was received by Acorn Rural Property Consultants at 17:13 this evening and the Parish Council need to seek legal advice ahead of this being discussed in a public forum at a Parish Council meeting. The Clerk is to seek an extension to allow this application to be discussed at a planning meeting on the provisional date of Tuesday, 24<sup>th</sup> November at 7 pm.

10/20/00008/STP – Valley Farm – erection of a single storey extension to the rear (south) elevation.

The Parish Council agreed to support the application by a majority.

10/20/00010/STP – Land to the West of Owls Hill Barn – application for the prior approval of the installation of a 1 x 15 m tall mast.

The Parish Council opposed this application by a majority and felt further consultation is required by the community through the Parish Council and alternative sites to be explored outside of an AONB.
